16 – 19 Bursary Guidelines for Applications

Please be aware that the 16-19 Bursary is different from the Educational Maintenance Allowance that ceased on 1 January 2011 to new applicants. The new 16–19 Bursary Fund allocated by the government is managed by Springwood Sixth Form and is a limited sum of money. There are two elements to this fund: -

1. Bursary Fund

This is aimed at students who are most in need. To be eligible for the bursary of £1,200 a year you must be a **student (not parents)** who is either;

- In care;
- A care leaver;
- In receipt of income support; or,
- A disabled young person receiving Employment Support Allowance and Disability Living Allowance.

2. Discretionary Award

Springwood Sixth Form will also operate a discretionary support system for other 16-19 students who face genuine financial difficulties.

Application Process

Eligibility will be determined via formal application process. You must ensure that all questions on the application form are answered clearly and attach relevant supporting documents.

Please return your completed form and supporting evidence to the Sixth Form Office, Springwood High School, Queensway, Kings Lynn, Norfolk, PE30 4AW.

Springwood Sixth Form will process the information and will advise you, in writing, of the outcome.

If you wish to appeal this decision please write to Mr J Hirst, Sixth Form Office, Springwood High School, Queensway, Kings Lynn, Norfolk, PE30 4AW.

All eligible payments will be subject to compliance with the Sixth Form Code of Conduct, Attendance Policy and adherence to subject work deadlines. Payments will be back-dated to the start of the courses the student has enrolled upon.

All bursary payments will be made directly into the student's personal nominated account, each half term, and will be subject to the conditions laid down by the Sixth Form.

In Year applications will be considered and applications are to be with Miss Coleridge by the 15th of each month, subject to funds being available.

Please ensure you have read and understood the Sixth Form's Code of Conduct, Attendance Policy and are familiar with subject work deadlines before completing this form.
