1. Purpose of the Plan

This plan examines potential risks and issues that could cause disruption to the exams process at Springwood High School. By outlining actions/procedures to be invoked in case of disruption it is intended to mitigate the impact these disruptions have on our exam process.

Alongside internal processes, this plan is informed by the Ofqual *Exam system contingency plan: England, Wales and Northern Ireland* which provides guidance in the publication 'What schools and colleges and other centres should do if exams or other assessments are seriously disrupted' and the JCQ 'Joint Contingency Plan in the event of widespread disruption to the Examination System in England, Wales and Northern Ireland'.

This plan also confirms Springwood High School is compliant with the JCQ regulation (section 5.3, *General Regulations for Approved Centres 2023/24*) that the centre 'has in place a written examination contingency plan which covers all aspects of examination administration. This will allow members of the senior leadership team to act immediately in the event of an emergency or staff absence'.

Internal Governance

The head of centre is to provide support and guidance to examination office staff and along with senior leaders with the responsibility for examinations will ensure the integrity and security of examinations and assessments throughout the examination series. In the event that the head of centre or any senior member is absent for a prolonged period during anytime in the examination season the deputy head of centre will be responsible for overseeing all examination procedures and administration.

3. Possible Causes of Disruption to the Exam Process

- a) Exam officer extended absence at key points in the exam process (November, January and Summer Exam seasons)

Criteria for Implementation of the Plan

Key tasks required in the management and administration of the exam cycle not undertaken including:

Planning

- *annual data collection exercise not undertaken to collate information on qualifications and awarding body specifications being delivered*
- *annual exams plan not produced identifying essential key tasks, key dates and deadlines*
- *sufficient invigilators not recruited*

Entries

- *awarding bodies not being informed of early/estimated entries which prompts release of early information required by teaching staff*
- *candidates not being entered with awarding bodies for external exams/assessment*
- *awarding body entry deadlines missed or late or other penalty fees being incurred*

Pre-exams

- *invigilators not trained or updated on changes to instructions for conducting exams*
- *exam timetabling, rooming allocation; and invigilation schedules not prepared*
- *candidates not briefed on exam timetables and awarding body information for candidates*
- *confidential exam/assessment materials and candidates' work not stored under required secure conditions*
- *internal assessment marks and samples of candidates' work not submitted to awarding bodies/external moderators*

Exam time

- *exams/assessments not taken under the conditions prescribed by awarding bodies*
- *required reports/requests not submitted to awarding bodies during exam/assessment periods, for example very late arrival, suspected malpractice, special consideration*
- *candidates' scripts not dispatched as required for marking to awarding bodies*

Results and post-results

- *access to examination results affecting the distribution of results to candidates*
- *the facilitation of the post-results services*

Centre actions to mitigate the impact of the disruption

- Data collections and key exam dates- These are held in the exam admin file (containing key dates of each exam cycle) from which exams can be organised if the exams officer is absent.
- Entries- Estimated entries list will be kept in the exam admin file to provide exam information for the current academic year. When entries are made a list of entry names will be given to the HODs for checking.
- Pre-exam time– Record of invigilator training will be kept in the exam admin file. Summary timetable will be sent to all invigilators prior to the exam season in order to make sure the required number of invigilators are available. NEA marks are obtained from HODs and submitted via secure areas of the relevant website. Moderation samples to be dispatched using postal labels provided.
- Information on post results procedures communicated to students prior to their final exam and posted on the school website.

- b) SENCo extended absence at key points in the exam cycle

Criteria for Implementation of the Plan

Key tasks required in the management and administration of the access arrangements process within the exam cycle not undertaken including:

Planning

- *candidates not tested/assessed to identify potential access arrangement requirements*
- *centre fails to recognise its duties towards disabled candidates as defined under the terms of the Equality Act 2010*
- *evidence of need and evidence to support normal way of working not collated*

Pre-exams

- *approval for access arrangements not applied for to the awarding body*
- *centre-delegated arrangements not put in place*
- *modified paper requirements not identified in a timely manner to enable ordering to meet external deadline*
- *staff (facilitators) providing support to access arrangement candidates not allocated and trained*

Exam time

- *access arrangement candidate support not arranged for exam rooms*

Centre actions to mitigate the impact of the disruption

- *Ensure all relevant candidates are tested in a timely manner in order to submit applications to JCQ for approval. All evidence to be retained by the SENCO ready for inspection.*
- *Exams officer to liaise with SENCO continuously throughout the year to ensure access arrangements are up to date.*

- c) Teaching staff extended absence at key points in the exam cycle

Criteria for Implementation of the Plan

Key tasks not undertaken including:

Early/estimated entry information not provided to the exams officer on time; resulting in pre-release information not being received

Final entry information not provided to the exams officer on time; resulting in candidates not being entered for exams/assessments or being entered late/late or other penalty fees being charged by awarding bodies

Non-examination assessment tasks not set/issued/taken by candidates as scheduled

Candidates not being informed of centre assessed marks before marks are submitted to the awarding body and therefore not being able to consider appealing internal assessment decisions and requesting a review of the centre's marking

Internal assessment marks and candidates' work not provided to meet awarding body submission deadlines

Centre actions to mitigate the impact of the disruption

- *HOD and/or SLT to be responsible for ensuring all NEA deadlines are met and candidates are informed of their marks as per school policy.*
- *Exams officer to send out deadline reminders.*

d) Invigilators - Lack of Appropriately Trained Invigilators or Invigilator Absence

Criteria for Implementation of the Plan

Failure to recruit and train sufficient invigilators to conduct exams

Invigilator shortage on peak exam days

Invigilator absence on the day of an exam

Centre actions to mitigate the impact of the disruption

- Cover staff trained and available to step in if required
- All invigilators to attend training sessions. JCQ updates and training notes to be emailed in the case of absence.
- Invigilator recruitment, if required, to take place at the beginning and throughout the academic year.

e) Exam rooms - lack of appropriate rooms or main venues unavailable at short notice

Criteria for implementation of the plan

Exams officer unable to identify sufficient/appropriate rooms during exams timetable planning

Insufficient rooms available on peak exam days

Main exam venues unavailable due to an unexpected incident at exam time

Centre actions to mitigate the impact of the disruption

- Rooms to be booked in advance and referred to SLT if issues arise.

f) Failure of IT Systems

Criteria for implementation of the plan

MIS system failure at final entry deadline

MIS system failure during exams preparation

MIS system failure at results release time

Centre actions to mitigate the impact of the disruption

- Contact awarding bodies immediately for advice and guidance
- Make alternative arrangements with other schools within the Trust
- Robust backup systems are in place

g) Cyber Security attack

The Cyber attack policy is held by Lee Jackson and due to the sensitive information held in the policy we are unable to hold a copy in our policy file. In the event of a Cyber attack, contact Lee Jackson who is based at Springwood High School. If he is not available we can obtain his telephone number from the IT Department.

h) Emergency evacuation of the exam room (or centre lock down)

Criteria for implementation of the plan

Whole centre evacuation (or lock down) during exam time due to serious incident resulting in exam candidates being unable to start, proceed with or complete their exams

Centre actions to mitigate the impact of the disruption

- Contact awarding bodies immediately for advice and guidance
- Use JCQ contingency day

i) Disruption of teaching time – centre closed for an extended period

Criteria for implementation of the plan

Centre closed or candidates are unable to attend for an extended period during normal teaching or study supported time, interrupting the provision of normal teaching and learning

Centre actions to mitigate the impact of the disruption

- Provision of remote learning
- Springwood High school may advise candidates to sit examinations in an alternative series.

j) Candidates unable to take examinations because of a crisis – centre remains open

Criteria for implementation of the plan

Candidates are unable to attend the examination centre to take examinations as normal

Centre actions to mitigate the impact of the disruption

- Awarding body should be informed and alternative centre should be arranged.

k) Centre unable to open as normal during the exams period
(including in the event of the centre being unavailable for examinations owing to an unforeseen emergency)

Criteria for implementation of the plan

Centre unable to open as normal for scheduled examinations

Centre actions to mitigate the impact of the disruption

- Alternative arrangements made with other schools within the trust or local schools/centres

l) Disruption in the distribution of examination papers

<u>Criteria for implementation of the plan</u> <i>Disruption to the distribution of examination papers to the centre in advance of examinations</i>
<u>Centre actions to mitigate the impact of the disruption</u> <ul style="list-style-type: none">• Copies of papers to be accessed electronically and printed and stored under secure conditions.• Awarding bodies to be contacted for advice and guidance• Head of Centre or Mr Wills will access the Exam Board(s) for any downloads that are required on the day of the exam

m) Disruption to the transportation of completed examination scripts

<u>Criteria for implementation of the plan</u> <i>Delay in normal collection arrangements for completed examination scripts</i>
<u>Centre actions to mitigate the impact of the disruption</u> <ul style="list-style-type: none">• Awarding bodies to be contacted for instructions. Scripts to be stored securely at all times.

n) Assessment evidence is not available to be marked

<u>Criteria for implementation of the plan</u> <i>Large scale damage to or destruction of completed examination scripts/assessment evidence before it can be marked</i>
<u>Centre actions to mitigate the impact of the disruption</u> <ul style="list-style-type: none">• Applications for special consideration to be made• Candidates advised that they may need to re-sit examinations in a different series.

o) Centre unable to distribute results as normal or facilitate post results services (including in the event of the centre being unavailable on results day owing to an unforeseen emergency)

<u>Criteria for implementation of the plan</u> <i>Centre is unable to access or manage the distribution of results to candidates, or to facilitate post-results services</i>
<u>Centre actions to mitigate the impact of the disruption</u> <ul style="list-style-type: none">• Springwood will make arrangements to access and distribute its results at an alternative site, in agreement with the relevant awarding organisation• Springwood will arrange to make post results requests from an alternative location

4. Further guidance to inform procedures and implement contingency planning

a) Ofqual

What schools and colleges and other centres should do if exams or other assessments are seriously disrupted:-

1. Contingency planning

You should prepare for possible disruption to exams and other assessments as part of your emergency planning and make sure your staff are aware of these plans. When drafting contingency plans, you should consider the following guidance...

2. Disruption to assessments or exams

In the absence of any instruction from the relevant awarding organisation, you should make sure that any exam or timetabled assessment takes place if it is possible to hold it. This may mean relocating to alternative premises. You should discuss alternative arrangements with your awarding organisation if:

- the exam or assessment cannot take place
- a student misses an exam or loses their assessment due to an emergency, or other event, outside of the student's control

3. Steps you should take

3.1 Exam planning - Review contingency plans well in advance of each exam or assessment series. Consider how, if the contingency plan is invoked, you will comply with the awarding organisation's requirements.

3.2 In the event of disruption

- Contact the relevant awarding organisation and follow its instructions.
- Take advice, or follow instructions, from relevant local or national agencies in deciding whether your centre is able to open.
- Identify whether the exam or timetabled assessment can be sat at an alternative venue, in agreement with the relevant awarding organisation, ensuring the secure transportation of questions papers or assessment materials to the alternative venue.
- Where accommodation is limited, prioritise students whose progression will be severely delayed if they do not take their exam or timetabled assessment when planned.
- In the event of an evacuation during an examination please refer to JCQ's '[Centre emergency evacuation procedure](#)'.
- Communicate with parents, carers and students any changes to the exam or assessment timetable or to the venue.
- Communicate with any external assessors or relevant third parties regarding any changes to the exam or assessment timetable.

3.3 After the exam

- Consider whether any students' ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration.
- Advise students, where appropriate, of the opportunities to take their exam or assessment at a later date.
- Ensure that scripts are stored under secure conditions.
- Return scripts to awarding organisations in line with their instructions. Never make alternative arrangements for the transportation of completed exam scripts, unless told to do so by the awarding organisation.

4. Steps the awarding organisation should take:

4.1 Exam planning

Establish and maintain, and at all times comply with, an up-to-date, written contingency plan.

Ensure that the arrangements in place with centres and other third parties enable them to deliver and award qualifications in accordance with their conditions of recognition.

4.2 In the event of disruption

1. Take all reasonable steps to mitigate any adverse effect, in relation to their qualifications, arising from any disruption.
2. Provide effective guidance to any of their centres delivering qualifications.
3. Ensure that where an assessment must be completed under specified conditions, students complete the assessment under those conditions (other than where any reasonable adjustments or special considerations require alternative conditions).
4. Promptly notify the relevant regulators about any event which could have an adverse effect on students, standards or public confidence.
5. Coordinate its communications with the relevant regulators where the disruption has an impact on multiple centres or a wide range of learners.

4.3 After the exam

Consider any requests for special consideration for affected students. For example, those who may have lost their internally assessed work or whose performance in assessments or exams could have been affected by the disruption.

5. If any students miss an exam or are disadvantaged by the disruption

If some of the students have been adversely affected by the disruption, you should ask the awarding organisation about applying for special consideration.

Decisions about special consideration, when it is or is not appropriate, is for each awarding organisation to make. Their decisions might be different for different qualifications and for different subjects.

6. Wider communications

The regulators, [Ofqual](#) in England, [Qualifications Wales](#) in Wales and [CCEA](#) in Northern Ireland, will share timely and accurate information, as required, with awarding organisations, government departments and other stakeholders.

The [Department for Education](#) in England, the [Department of Education](#) in Northern Ireland and the [Welsh Government](#) will inform the relevant government ministers as soon as it becomes apparent that there will be significant local or national disruption; and ensure that they are kept updated until the matter is resolved.

Awarding organisations will alert the [Universities and Colleges Admissions Service](#) (UCAS) and the [Central Applications Office](#) (CAO) about any impact of the disruption on their deadlines and liaise regarding student progression to further and higher education.

Awarding organisations will alert relevant professional bodies or employer groups if the impact of disruption particularly affects them.

7. Widespread national disruption

In the event of widespread sustained national disruption, the government departments will communicate with regulators, awarding organisations and centres prior to a public announcement. Regulators will provide advice to government department on implications for exam timetables.

b) JCQ

- 15.1 The qualification regulators, JCQ and government departments responsible for education have prepared and agreed information for schools and colleges in the event of examinations being seriously disrupted. This jointly agreed information will ensure consistency of response in the event of major disruption to the examinations system affecting significant numbers of candidates.
